Include: PI, Name of Organization/Entity, Scope of Work, and an explanation of why the work is best performed outside the U.S. Submit to OSRA for review and counter-signature, and OSRA will submit to NIH	Requires a prior approval letter for the NIH jointly signed by the PI and OSRA	OSRA Specialist
Have been provided funding from a foreign institution that has routed through WRG-SP (OSRA) as a WCM project	Ensure the funding is included on Current and Pending Support/Other Support		
Have been provided funding from a foreign institution AND that funding has not routed through WRG SP - OSRA as part of a WCM project.	List the funding on Current and Pending Support/Other Support.
