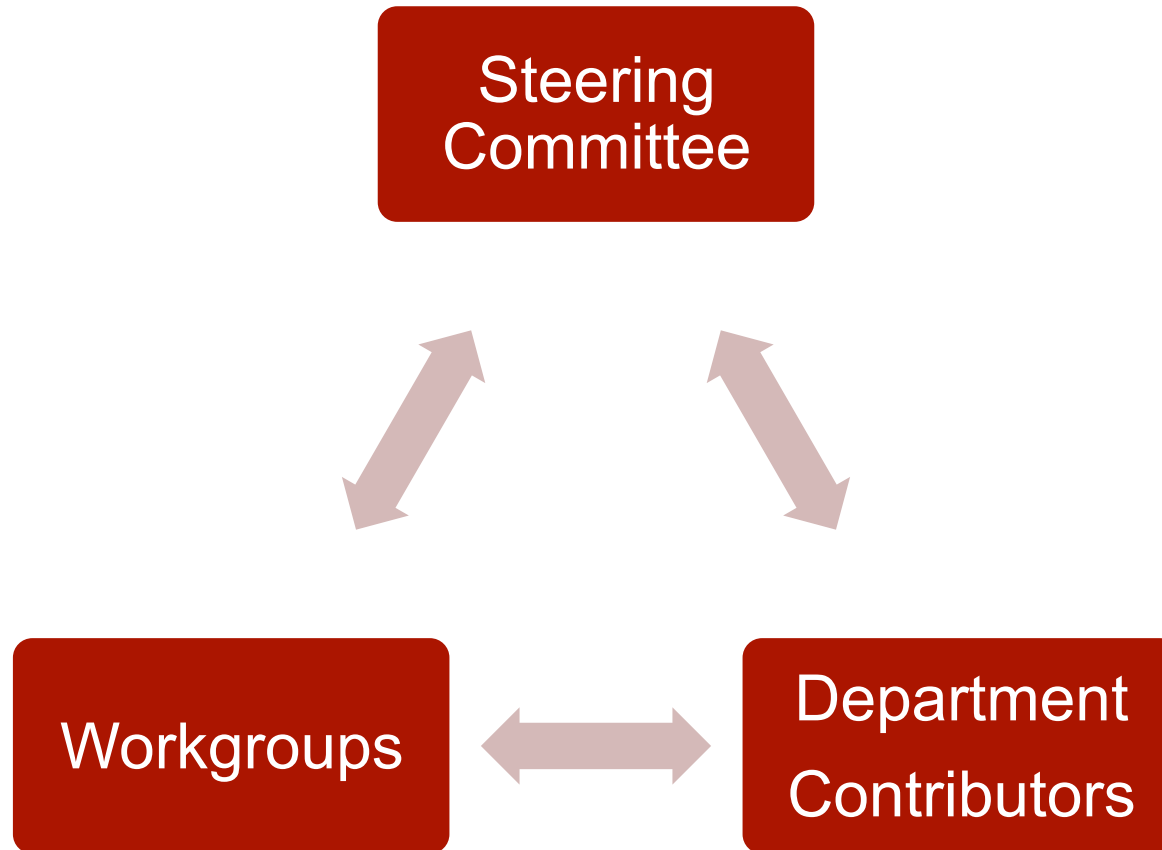

WCMC UG Implementation Plan & Status

1. Identify WCMC personnel to chair steering committee and workgroups. **Done!**
2. Analyze changes in UG and assess changes needed to existing policies and procedures. **Done!**
3. Continually review agency-specific implementation plans. **Ongoing!**
4. Create checklists/tools highlighting important changes impacting pre-award and post-award as a result of UG. **Done!**
5. Training/workshops will be available. **See next slide for dates!**
