Response to Michael Lauer Communication:

## Association of American Medical Colleges (AAMC)

FOCI Community,

We'd like to update you on some immediate and upcoming changes to the NIH <u>FAQs</u> related to the recent <u>Guide Notice</u> on reporting of foreign activities. Please also see previous emails and the related <u>issue brief</u> for more background information.

As many of you had noted, the plain reading of the <u>FAQs related to Other Support</u> would have vastly increased the amount of information included in grant applications, including unpaid consulting or activities unrelated to an investigator's research. In conversation today with Mike Lauer, Deputy Director of the Office of Extramural Research (OER) at NIH, we communicated your concerns. The OER was very receptive to the issues we raised and wholly agreed that the phrasing of the FAQs could result in the misperception that NIH wanted far more information to be included in the applications than they do.

In the next day or so, the FAQ question #6 on when outside activities should be reported as Other Support will be removed from the website and in the coming days and weeks a number of other changes clarifying NIH's requirements will be included there. We are actively engaged and coordinating these clarification efforts not only with NIH, but with the other higher education associations, COGR, AAU, and APLU.

The primary message to you all from NIH is that the agency has not substantially changed its expectations of what should be reported but is working to clarify its guidance to respond to recent cases in the realm of undue foreign influence in which activities or resources that should have been reported to NIH and to institutions had not been disclosed. We will keep you updated with each of these changes and I urge you to contact me with any specific concerns or examples that would be useful in thinking through these complex questions of what NIH needs to know to make decisions about whether a proposal it is considering funding may raise budgetary overlap or time commitment concerns.
